Courses available at Exmouth District High School

Courses offered face to face at Exmouth District High School are **dependent on meeting minimum student numbers**.

Courses offered by SIDE (Schools of Isolated Distant Education) are varied and extensive. The method of study is a combination of written and online classes. Students have computers and internet access available at school to complete these courses. For further information, please go to the website www.side.wa.edu.au

All Western Australian Certificate of Education (WACE) courses consist of units, each with their own syllabus. Students are encouraged to study units appropriate to their level of ability. We strongly encourage students to choose courses that are realistic but also academically challenging.

Note *** English is a Compulsory course for years 11 & 12.

Typically:

University-bound students study a program containing courses over their senior secondary years called ATAR Year 11 and ATAR Year 12.

Students who are planning on going into training through TAFE or at a private Registered Training Organisation, or directly into the workforce, typically study General Year 11 and General Courses Year 12 and/or TAFE certificates.

Students requiring practical and supported learning to develop the skills required to be successful upon leaving school or in the transition into General courses will typically study Foundation Courses and possibly some Certificate courses. However, this pathway needs to be negotiated with the school.

Students in General pathway must study 5 General courses or equivalent in Year 12, from 2022.

It is very important when selecting a course that attention is paid to **minimum entry requirements** and the **teachers' recommendations** regarding indicators of the student's successful completion of each course.

The grid below is an example showing courses used for different pathways that may be chosen.

COURSE SELECTION INSTRUCTIONS

Although the school makes every effort to accommodate each student's course choices, low numbers of students choosing a course and/or timetable clashes may result in students having to re-select. You will be informed should this eventuate. It is your responsibility to ensure that your selections qualify you for any future course or desired career pathways and that these courses are within your ability.

- 1. Choose your first 6 courses/endorsed programs or TAFE course preferences from EDHS Handbook Senior School Courses. Write them on page 4.
- 2. Choose 2 reserve courses or VET Training course/endorsed program. (To assist with the planning of choices, students are asked to choose two courses to act as "reserves" in case original selections cannot be offered.)

When you have chosen the 6 courses and your two reserve courses, submit your Course Selection sheet (page 4) to the Front Office. If a course is not recommended and you still wish to undertake the course, you and your parents must meet with a deputy.

Please note:

Approval: On the basis of past performance and current achievement, this selection is:

- 1. **Recommended**: The student is considered able to cope with this course.
- 2. **Will need to work harder:** Students need to ensure they complete all required work and undertake a regular study schedule than previously demonstrated, to meet the demands of the course.
- 3. **Not recommended**: This course is considered inappropriate based on teacher's professional judgement for this student and parents are asked to contact a deputy for further information. If parents wish their child to still undertake this course, they are asked to sign on page 4.

Reserve courses: These courses are chosen in case up to two of the original six courses do not run or cannot be studied due to timetable clashes. It cannot be guaranteed that all courses will run.

Parent or guardian: please carefully check your selections with your son/daughter, then sign on Page 4.

There is a strong expectation that students are counselled into the most challenging courses and pathways they can complete. We also need to maintain a focus on the best interests of our students. For senior secondary students, this means leaving school with the strongest possible range of opportunities for their future.

It is expected that students and parents are aware of the increased options young people have if they are to successfully complete ATAR level studies, and to encourage all vocational students to pursue challenging courses, especially in English and Mathematics.

If students, in the General courses will have not completed 5 General courses or equivalent by the end of year 12, it compromises their ability to receive WACE.

- Some courses may not be timetabled or may be moved on the grid due to the business needs of the school. To gain an ATAR entry to university, students must study a minimum of 5 courses that lead to ATAR exams, including an English course.
- Direct Entry to University or TAFE courses may require the completion of pre-requisite or recommended courses in Year 11 & 12
